

# 2019 EUROPEAN ELECTIONS VOTE AND ROAM COMPETITION

### I. TERMS AND CONDITIONS FOR PARTICIPANTS

### **GENERAL RULES**

- Everyone who runs an Instagram or Facebook account, is under age of 31 during the time of competition and gives a vote in 2019 European Elections, can become a participant of this competition.
- By uploading photo with necessary tags and captions, participants agree to the terms and conditions of the competition.
- The competition is taking place during 2019 European Elections, i.e. from 23 to 26 May 2019.
- Participation in the competition is free of charge.

## **PARTICIPATION**

- Participation is limited to one entry (posted picture) per person.
- As "entry" we consider a picture posted on Instagram or Facebook via participant's profile under following conditions.
- Posted picture shall:
  - relate to the 2019 European Elections (e.g. picture of participant in front of polling station...);
  - this <u>picture shall not break any national law</u> regarding the process of elections, therefore pictures inside of the voting booth, of the voting ballot and so on are not acceptable;
  - pictures shall tag the GiveAVote Instagram (@giveavote\_eu) or Facebook profile (@GiveAVoteEU) and use following format for the caption:
     #ThisTimeIVoted in the #EUelections2019 because .... (participant's reason why he/she voted). How about you? What do you care about? If you give a shit, #GiveAVote
  - Caption "If you give a shit, #GiveAVote" must be in English, other parts of caption could be in another language.
- Pictures with inappropriate language and/or inappropriate content that promotes violence, undermines human dignity and the basic rights and freedoms of others are not admissible.



- EYCA shall, at its sole discretion, determine whether or not each entry complies with the above conditions and reject entries it deems not compliant at any time, without notice.
- If a participant is found to have manipulated the competition in any way, EYCA reserves the right to eliminate such participant from the competition.

# **WINNERS AND AWARDS**

- Winners will be chosen in a raffle draw during the week following the 2019 European Elections (i.e. 27-31 May 2019). Winners will be contacted by direct message on Instagram or Facebook if participants shared their photo on Instagram, they will be connected via Instagram message; if they posted their photo using Facebook, then via Facebook message. Winners can be also announced at the website giveavote.eu however, such public announcement of winners is solely up to EYCA's decision.
- The participation in the competition cannot give rise to any legal claims or rights to compensation. Any legal action is excluded.
- Prizes are 10 Interrail Global Passes with validity 7 days in 1 month, 2<sup>nd</sup> class. Seat reservations are not included, nor travel or health insurance. Each prize also includes the sum of 400 EUR to cover other expenses related to the trip.
- The winners have 6 months from the date of announcing the winners to redeem the prize. The winners must inform EYCA about their travel dates at least 1 month in advance to allow time for passes to be issued and posted to their address.
- Prizes are not transferable.
- After the winners inform EYCA of their desired travel dates, EYCA will require from winners their email addresses with the aim to put them in touch with Interrail for the purpose of issuing their Interrail Pass.
- By entering and participating, the participant agrees to hold harmless, defend and indemnify Instagram as well as Facebook from and against any and all claims, demands, liability, damages or causes of action (however named or described), losses, costs or expenses, with respect to or arising out of or related to (i) participant's participation in this competition, or (ii) participant's participation in any prize related activities, acceptance of a prize and/or use or misuse of a prize (including, without limitation, any property loss, damage, personal injury or death caused to any person(s). This promotion is in no way sponsored, endorsed or administered by, or associated with Instagram or Facebook. Specific terms and conditions of Instagram or Facebook may apply.

### **DISQUALIFICATION AND DISCLAIMERS**

- EYCA reserves the right to disqualify any entry considered not to have followed and respected the conditions outlined above without any claim for compensation.
- In cases of suspected abuse, manipulation or any prohibited or unlawful use of the competition, participants concerned shall be immediately excluded from the competition without notice.
- Participants assume full responsibility for their entry.
- No responsibility will be taken for any damaged caused to participants due to unforeseen circumstances caused by third parties.



- EYCA warns participants that prizes could be subject to income tax in accordance
  with the winner's national applicable law. In such case every financial, legal, tax or
  other obligations regarding winning the award shall be fully executed by the winner,
  and winner is not entitled to claim any compensation from EYCA regarding mentioned
  obligations.
- EYCA reserves the right to amend the publicised conditions or to cancel the competition providing that amendment or cancellation is publicised in the same manner that the conditions of this competition are publicized.

  our decision we may announce winners at webpage giveavote.eu by showing the
  results of a raffle draw and chosen pictures.
- We process your personal data on the ground of your consent. You are providing your consent participating into the competition by posting a picture related to 2019 European Elections with captions as required in terms and conditions.
- Your personal **data gathered by** participation in this competition are:
  - o every participant picture and profile (Instagram or Facebook profile);
  - in case you become winner among above stated also your email address, with the aim to connect you with Interrail to issue your award (Interrail Global Pass).
- EYCA is entitled to provide your personal data to the third party. Third parties to whom we will provide your personal data, are: Instagram, Facebook, our cloud provider, Interrail.
- Your personal data will be stored since their collection as follows:
  - pictures posted at your Instagram or Facebook profile for necessary amount of time; they will be deleted at latest by the 6 months after end of the competition;



- email of winner will be deleted immediately after the claiming the prize and creation of winner's Interrail Global Pass;
- After that time, we will use your personal data only in anonymised or pseudonymised way and only for statistic purpose; we will take all necessary measures to protect them.
- We do not transfer your personal data outside of EU.
- You have the following rights, under the regulation of the applicable legislation:
  - right to withdraw your consent with personal data processing; withdrawal of your consent will not affect lawfulness of processing based on consent before its withdrawal.
  - o the right to request from the controller access to your personal data
  - the right to rectification of personal data,
  - o right to erasure of personal data,
  - o right to restriction of processing,
  - o right to object processing of personal data.
  - o the right to data portability,
